In the capacity as reorganisers for Departments & Stores Europe AB (*the Company*), the undersigned reorganisers hereby convey the following composition proposal.

Under the conditions set out in the attached reorganiser's report, appendix, the Company offers all creditors with unsecured claims a basic amount of SEK 10,000, plus a 25 percent composition on any excess amount.

Since your claim does not exceed SEK 10,000, **you will receive full distribution** if the composition proposal is approved. This means that you do not participate in voting on the composition.

The composition payment shall be made no later than January 31, 2021, or a later date when the district court's decision to approve the composition has entered into legal force.

Given that the creditors will receive significantly less in the event of a bankruptcy, we the reorganisers recommend that the composition proposal is accepted. You will receive information once the composition has been approved and gained legal force.
